


Log into the Face Mini.

How to log into the MSite Face Mini.


To log into the app, enter your login details:

- **Company:** usually **YourCompanyName**
(Must not contain spaces. Is not case sensitive)
- **Email Address:** **You@youremail.com**
(Must have a "User" account with *Supervisor App* permissions)
- **Password:** **Your password**
(Not needed if your company is using SSO)
- **Select, Sign in**



Initial Sync:

- First sync may take longer
(Internet connection required)

Face Mini Single Sign On. (sso)

How to perform a Manual Sync of the Face Mini.

Single Sign-On (SSO) is an authentication method that enables users to **securely authenticate** with **multiple** applications and websites by using just one set of credentials. This feature is available for the **MSite Face Mini**. If your business uses **SSO** the way you log in will be different.


The **Face Mini** log in page now displays **SSO** as a sign in option.

If **SSO** is enabled for your business, the **SSO** sign in option will highlight, once a **valid email** address is entered.

If using **Microsoft Authenticator**, you will be required to submit your password for the account.

You will now be required to complete your **authentication** by entering the **number** shown on screen, into the **Microsoft Authenticator** app.

Then, **confirm** the authentication number to sign in. Once authenticated, you will be **logged in**.

Stand 60cm to 100cm away from the device.



Stand still and fit face to the predefined area.



Maintain a neutral facial expression.



Normal glasses are acceptable.



DO NOT wear PPE, masks or sunglasses.



DO NOT display two faces on the screen.


Worker Profile Image Capture.

It is **essential** for the optimisation of our facial recognition software to capture a **passport quality** photo.

Optimal Image Capture Guide.



- ✓ Taken against a plain light-coloured background
- ✓ Photo should be clear and in focus
- ✓ Neutral expression & mouth closed
- ✓ Both eyes open and visible
- ✓ You can wear glasses, but your eyes must be visible without any glare or reflection
- ✓ Even lighting on the face, no shadows and with sufficient contrast with the background
- ✓ A recent facial image should be used



- ✗ No PPE or head coverings (unless it's for religious or medical reasons)
- ✗ Nothing covering your face

- ✗ No hair covering eyes
- ✗ No portion of the face should be cropped
- ✗ No sunglasses or tinted glasses

A. No, *Find My Phone* is not available for the Face Mini.





